## **Part II- Policy Document**

## **Policy Terms and Conditions**

#### **B.1** Preamble

The Add-on policy can only be bought along with Base Policy either on Policy Issuance or on renewal and cannot be bought as standalone or as a separate Policy.

This Policy is a contract of insurance issued by Royal Sundaram General Insurance Co. Limited (hereinafter called the 'Company') to the proposer mentioned in the schedule (hereinafter called the 'Insured') to cover the person(s) named in the schedule (hereinafter called the 'Insured Persons'). The policy is based on the statements and declaration provided in the proposal Form by the proposer and is subject to receipt of the requisite premium.

## **B.2** Operative Clause

The insurance cover provided under this Policy to the Insured Person up to the Sum Insured is and shall be subject to (a) the terms and conditions of this Policy and (b) the receipt of premium, and (c) Disclosure to Information Norm (including by way of the Proposal form or Information Summary Sheet) for Yourself and on behalf of all persons to be insured. Please inform Us immediately of any change in the address, nature of job, state of health, or of any other changes affecting You or any Insured Person.

If any claim arising as a result of an Illness or Injury that occurred during the Policy Period becomes payable, then we shall pay the benefits in accordance with terms, conditions (including sub limits, Co-payment if any) and exclusions of the Policy subject to availability of Sum Insured and Cumulative Bonus (if any).

## **C** Definitions

The terms defined below and at other junctures in the policy have the meanings ascribed to them wherever they appear in this Policy and, where, the context so requires, references to the singular include references to the plural; references to the male includes the female and references to any statutory enactment includes subsequent changes to the same.

## C.1 Standard Definitions

All other DEFINITIONS as defined in "SECTION C: DEFINITIONS" in the Opted Base Policy Wordings will be applicable to Add-on cover.

## **C.2** Specific Definitions

All other DEFINITIONS as defined in "SECTION C: DEFINITIONS" in the Opted Base Policy Wordings will be applicable to Add-on cover.

Any reference to any statute shall be deemed to refer to any replacement or amendment to that statute.

## **D** Benefits Covered

The Policy covers Reasonable and Customary Charges incurred towards the specified expenses as per the below terms and conditions during the Policy Period for an Illness, Accident or condition described below if this is contracted or sustained by an Insured Person during the Policy

Period and subject always to the Sum Insured, any sub limit specified in the Product Benefits Table, the terms, conditions, limitations and exclusions, Co-pay (if any) mentioned in the Policy.

## **D.1.1** Voluntary Co-Payment

Each and every claim under the Base Policy shall be subject to a Co-payment (as per percentage opted by you) applicable to claim amount admissible and payable as per the terms and conditions of the Policy. The amount payable shall be after deduction of the co-payment.

### Co-Payment options Available under this Add-on

5%, 10%, 15%, 20%, 25% and 30% on each and every claim made in base policy.

### D.1.2 General conditions applicable on this add-on

- 1. In case of any other co-pay in the policy apart from co-pay separately opted by the customer, co-payment will be additive in nature and however maximum co-pay will be limited to 50%.
- 2. This Add-on Cover cannot be opted during the mid-term of Base policy.
- 3. Customers will have options to increase, decrease or delete co-pay at the time of renewal. However, deletion or decrease of co-payment will be subject to Tele-underwriting.

## **E** Exclusions

All exclusions as mentioned in the Base Plan unless otherwise stated and covered in Section D of this Add-on policy wordings.


