

Introduction:

'Baggage Insurance' protects accompanied baggage of a traveller from unforeseen damage or loss. The policy provides peace of mind and financial safety net to the customers in the event of unexpected travel mishaps.

Who can avail of "Baggage Insurance"?

This Policy is available for any Business or corporate entities who travels away from home, especially those who are frequent travellers or those who carry valuable items.

What is the coverage under the policy?

The policy is intended to cover accompanied baggage (not dealer's stock or traveller's samples) during a specified journey by air, sea, rail or road undertaken by the insured along with/without his family members against the risks of loss or damage to their baggage caused by Fire, Riot & Strike, Terrorist Activity, Theft or Accident.

The policy provides cover at any time during the period of insurance whilst the insured is travelling on tour and or holiday.

The policy covers travel within India only.

What is the Sum Insured under the Policy?

The Sum insured will be the value of the property/items declared by the insured for Baggage Insurance.

What are the exclusions under the policy?

- 1. Any loss or damage occurring during routine travel which are not caused by insured peril.
- Damage caused by any process of cleaning, dyeing or bleaching, restoring, repairing or renovation or deterioration arising from wear and tear, moth, vermin, insects or mildew or any other gradually operating cause.
- 3. Breakage, cracking or scratching of crockery, glass, cameras, binoculars, lenses, sculptures, curios, pictures, musical instruments, sports gear and similar articles of brittle and fragile nature, unless caused by fire or accident to the means of conveyance.
- 4. Loss or damage caused by mechanical or electrical derangement/breakdown of any article, unless caused by accidental external means.
- 5. Over winding and denting or internal damage of watches and clocks.
- 6. Loss or damage to money, securities, manuscripts, deeds, bonds, bills of exchange, promissory notes, stocks or share certificates, stamps and travel tickets or travellers cheques, business books or documents unless specifically insured.
- 7. Loss, destruction or damage caused by or arising from the leakage, spilling or excluding of liquids oils or material of a like nature or articles of dangerous or damaging nature.
- 8. Theft from any car except car of fully enclosed saloon type having at the time all the doors, windows and other openings securely locked and properly fastened.
- 9. Loss of or damage to articles which did not form part of the baggage when the journey commences, unless specifically declared and accepted by the Company.
- 10. Loss, destruction of or damage to articles of due to inherent vice of commodity.
- 11. Loose articles such as sticks, umbrellas, sun shades, fans, deck chairs and property in use on the voyage or journey, or articles whilst being worn on the person or carried about.



- 12. Loss or damage, whether direct or indirect, arising from war, warlike operations, act of foreign enemy, hostilities (whether war be declared or not), civil war, rebellion, insurrection, civil commotion, military or usurped power, seizure, capture, confiscation, arrests, restraints and detainment by order of any Government or any other authority. In any action suit or other proceedings where the Company alleges that by reason of the above provisions any loss or damage is not covered by this insurance, the burden of proving that such loss or damage is covered, shall be upon the Insured.
- 13. Any loss or damage arising through delay, detention or confiscation by Customs or other governmental authorities.
- 14. a) Any loss, destruction or damage, to any property whatsoever or any loss or expense whatsoever, resulting or arising therefrom or any consequential loss, and any legal liability of whatsoever nature, directly or indirectly caused by or contributed to by or arising from ionising radiation or contamination by radioactivity from any source whatsoever.
 - b) Any loss, destruction, damage or legal liability, directly or indirectly caused by or contributed to, by or arising from Nuclear weapons material.
- 15. Consequential loss or legal liability of any kind.
- 16. Loss or damage due to contributed to by the Insured having caused or suffered anything to be done whereby the risks hereby insured against were unnecessarily increased.

What is the duration of the policy?

Policy will be issued for a period of one year.

What is the Claims procedure?

Submission: The Claim documents to be submitted by the insured are given below:

- 1. Claim form
- 2. FIR/Final Report
- 3. Proof in support of Cause of Loss/Operation of Insured peril
- 4. Books of Accounts
- 5. Stock Register
- 6. Repair/Reinstatement Bills
- 7. Proof of Reinstatement
- 8. CKYC documents PAN, ROC certificate, Aadhaar, GST Registration Certificate
- 9. Any other document: There may be specific requirements depending upon the merits of each case

<u>Process:</u> The company will assign a surveyor to assess and evaluate the loss. If the claim is found to be in order, as per the policy terms, conditions, or warranties and does not fall under the policy exclusions, we will offer a settlement of the claim to the insured. The claim will be processed, and payment will be made by online fund transfer.

<u>Turn Around Time for claims settlement</u>: 15 working days from the date of receipt of survey report or last document / clarification from the Insured / Surveyor whichever is later.

What is the cancellation process?

1. Your Policy may be cancelled by you at any time by giving fifteen (15) days' notice to Us in writing. The cancellation will take effect from the date We receive Your notice. Premium refund will be as per the Policy terms agreed between You and Us.



2. Your Policy may be cancelled by Us at any time by giving fifteen (15) days' notice to You in writing on the grounds of misrepresentation, fraud, on-disclosure of material facts or non-co-operation. The Policy will be cancelled without any refund in premium.

Your Policy will automatically be cancelled from the time Your business becomes insolvent or is wound up or is permanently discontinued or a liquidator, administrator, receiver, manager and / or trustee in bankruptcy is appointed to You or any of Your assets.

No refund of premium shall be due if the Insured has made a Claim under this Policy.

3. Insurance Ombudsman

If the Insured / insured member is not satisfied with the redressal of grievance through above methods, the insured / insured member may also approach the office of Insurance Ombudsman of the respective area/region for redressal of grievance as per Insurance Ombudsman Rules 2017. You can approach the Council for Insurance Ombudsman depending on the nature of grievance and financial implication, if any. Section 41 in the Insurance Act, 1938

41. Prohibition of rebates

(1) No person shall allow or offer to allow, either directly or indirectly, as an inducement to any person to take out or renew or continue an insurance in respect of any kind of risk relating to lives or property in India, any rebate of the whole or part of the commission payable or any rebate of the premium shown on the policy, nor shall any person taking out or renewing or continuing a policy accept any rebate, except such rebate as may be allowed in accordance with the published prospectuses or tables of the insurer: Provided that acceptance by an insurance agent of commission in connection with a policy of life insurance taken out by himself on his own life shall not be deemed to be acceptance of a rebate of premium within the meaning of this sub-section if at the time of such acceptance the insurance agent satisfies the prescribed conditions establishing that he is a bona fide insurance agent employed by the insurer.

(2) Any person making default in complying with the provisions of this section shall be liable for a penalty which may extend to ten lakh rupees.

Note: In case of any conflict, the terms and conditions mentioned in the policy document shall prevail.
